

- **The Use of "Sports Groups" Platform of Saudi Sports for All Federation (SFA).**

This online platform of the (SFA) (in the Kingdom of Saudi Arabia), herein referred to as "Platform", is available for use by any person who benefits from its services, and the access and use of "Platform" shall be subject to the Terms and conditions of Use, and the applicable laws in the Kingdom of Saudi Arabia. Therefore, the access and entry to "Platform" shall be considered an unconditional approval on the Terms and Conditions of Use, and an agreement on the online dealing with the (SFA) and all legal effects of that whether you are a registered user or not. Such approval shall be effective from the date of first use of "Platform" by any person or sports group. The terms of this Agreement shall be applicable to all users, beneficiaries and sports groups that benefit from the services of "Platform" or who represent them, act on their behalf or are allowed to use such services in any way "User or beneficiary" or "sports group". These terms shall also be applicable to all users, beneficiaries and sports groups directly and they shall guarantee that their representatives or who act on their behalf or are allowed to benefit from "Platform" services in any capacity or way will comply with such Terms and Conditions of Use.

Any amendment to these Terms and Conditions shall become effective immediately upon its announcement, unless otherwise indicated, and by continuing to use "Platform" after the announcement of any amendment shall mean the full acceptance of such amendment.

- **Information:**

The user shall agree to provide true, accurate, current and complete information, keep and update such information always in order to maintain its correctness, accuracy and completeness, and bear the responsibility for non-compliance with the foregoing.

- **User Liability:**

- **Restrictions of Use:**

- Provide or upload files that contain viruses or corrupted data on "Platform".

- Participate through "Platform" in illegitimate or illegal activities in the Kingdom of Saudi Arabia.
- Advertise - on "Platform" - any product or service that exposes us to violate any applicable law or regulation in any field.
- Use any means, software or procedure to intercept or attempt to intercept the proper operation of "Platform".

- **SFA Rights:**

The SFA shall reserve the right to change its services - without prior notice – that are not included in this Agreement, including, but not limited to, the procedures of access, documentation, programs and the provided system services.

The SFA shall also reserve the right to suspend or cancel the access of any user to the Service if it violates any of the terms of this Agreement, including, but not limited to, doing an act that causes damage to the system, users, or one of the internet users.

The SFA shall reserve the right to cancel the access of a user's account to the Service, if its consumption of such mean exceeds what is stated in the terms of this Agreement or the customary and reasonable use of such Service.

- **Guarantee the Rights of Use and Information Accuracy:**

The "user, beneficiary" or "sports group" guarantees and acknowledges that the SFA shall not bear any responsibility for the provided information. The user shall agree that the information it enters into the system is correct, and that the SFA shall have the right to use such information for the purposes of the activity and its related matters, including, but not limited to, research purposes.

- **Links from "Platform":**

The links to portals or other websites are provided for the purpose of convenience of users, and we are not responsible for the contents or authenticity of portals or websites we link to and do not certify contents therein, and the use of links to access such websites or portals shall be entirely the responsibility of the user.

We aim at replacing damaged links - that do not work - with other websites, but we cannot guarantee that such links will work permanently.

- **Antivirus Protection:**

We make every effort to check and test the contents of "Platform" at all stages of production, and we always advise users to run an anti-virus software on all materials that are downloaded from the Internet. - **Waiver of claims:**

Any communications or information that a user may send through "Platform", it shall not have the right to own them or ensure their confidentiality. - **Limitation of Liability:**
