Your privacy is critically important to us.

It is SFA's policy to respect your privacy regarding any information we may collect while operating our App. This Privacy Policy applies to <https://sportsforall.com.sa/> (hereinafter, "us", "we", or "SFA", or "<https://sportsforall.com.sa/>"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the App. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our App, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the App and does not apply to our collection of information from other sources. This Privacy Policy, together with the Terms and Conditions posted on our App, set forth the general rules and policies governing your use of our App. Depending on your activities when visiting our App, you may be required to agree to additional terms and conditions.

APP USERS

Like most Apps, SFA collects non-personally-identifying information of the sort that apps and servers typically make available, such as the device type, language preference, referring medium, and the date and time of each visitor request. SFA's purpose in collecting non-personally identifying information is to better understand how SFA's visitors use its App. From time to time, SFA may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its App. SFA also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users. SFA only discloses logged in user IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.

GATHERING OF PERSONALLY-IDENTIFYING INFORMATION

Certain visitors to SFA's Apps choose to interact with SFA in ways that require SFA to gather personally-identifying information. The amount and type of information that SFA gathers depends on the nature of the interaction. For example, we ask visitors who sign up on the App <https://sportsforall.com.sa/> as a new user to provide a name, nickname, mobile number, email address, date of birth, city and gender. Whereas if visitors would like to contact us through <https://sportsforall.com.sa/en/contact-us> we ask them to provide a name and email address.

SECURITY

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

ADVERTISEMENTS

Ads appearing on our App may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. This Privacy Policy covers the use of cookies by SFA and does not cover the use of cookies by any advertisers.

LINKS TO EXTERNAL SITES

Our Service may contain links to external sites that are not operated by us. If you click on a third party link, you will be directed to that third party's site. We strongly advise you to review the Privacy Policy and terms and conditions of every site you visit. We have no control over, and assume no responsibility for the content, privacy policies or practices of any third party sites, products or services.

SFA USES VARIETY OF 3RD PARTY SERVICES FOR REMARKETING

SFA (<https://sportsforall.com.sa/>) uses the remarketing services to advertise on third party Apps (including Google) to previous visitors of our site. It could mean that we advertise to previous visitors who haven't completed a task on our site, for example using the contact form to make an enquiry. This could be in the form of an advertisement on the Google search results page, or a site in the Google Display Network. Third-party vendors, including Google, use cookies to serve ads based on someone's past visits. Of course, any data collected will be used in accordance with our own privacy policy and Google's privacy policy. You can set preferences for how Google advertises to you using the Google Ad Preferences page, and if you want to you can opt out of interest-based advertising entirely by cookie settings or permanently using a browser plugin.

PROTECTION OF CERTAIN PERSONALLY-IDENTIFYING INFORMATION

SFA discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that (i) need to know that information in order to process it on SFA's behalf or to provide services available at SFA's App, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organizations may be located outside of your home country; by using SFA's App, you consent to the transfer of such information to them. SFA will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organizations, as described above, SFA discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental request, or when SFA believes in good faith that disclosure is reasonably necessary to protect the property or rights of SFA, third parties or the public at large.

If you are a registered user of <https://sportsforall.com.sa/> and have supplied your email address, SFA may occasionally send you an email to tell you about new features, solicit your feedback,

or just keep you up to date with what's going on with SFA. If you send us a request (for example via a support email or Contact Us <https://sportsforall.com.sa/contact-the-federation>), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. SFA takes all measures reasonably necessary to protect against unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

AGGREGATED STATISTICS

SFA may collect statistics about the behavior of visitors to its App. SFA may display this information publicly or provide it to others. However, SFA does not disclose your personally-identifying information.

COOKIES

To enrich and perfect your online experience, SFA uses "Cookies", similar technologies and services provided by others to display personalized content, appropriate advertising and store your preferences on your computer.

A cookie is a string of information that a App stores on a visitor's computer, and that the visitor's browser provides to the App each time the visitor returns. SFA uses cookies to help SFA identify and track visitors, their usage of <https://sportsforall.com.sa/> and their App access preferences. SFA visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using SFA's App, with the drawback that certain features of SFA's App may not function properly without the aid of cookies.
